TERMS DENOTING COMPARISON: THE SEMANTICS OF COMPARING FROM THE SIXTEENTH TO THE TWENTIETH CENTURY

From time immemorial, past events and forecasts served as templates for constructing and judging upon present and future. Whereas pessimists stressed human decline since the Golden Age, optimists praised progress bound to bring about salvation, communism, or market equilibrium. The comparisons between 'then' and 'now', or 'now' and 'later' not only marked perceived differences in history, but also stressed the politically and culturally relevant similarities. While the abundance of such and similar comparative evaluations is evident, few attempts have been made to track down their vocabularies/syntactic structures, and, most importantly, link these constructions to specific languages, periods, political disputes, or literary genres.

Featuring a small number of experts across relevant disciplines (conceptual history, history of ideas, intellectual history, discourse analysis), the workshop is aimed at laying the foundations for a large-scale interdisciplinary study of temporal comparisons.



The SFB's subproject Co3 is exploring the semantics of comparing in Europe since 1500. The inquiry proceeds on three levels: terms denoting practices of comparing, explicit definitions of comparing, and speech acts (sentences) that perform comparisons. The basic hypothesis for the early modern period is that comparisons in the form of analogies were on the decline, whereas progressive comparisons, embedded in perceptions of competition, were on the increase. Finally, since 1800, there has been a growing importance of comparisons that stress equivalence in spite of difference or even complete incomparability.
